

SUMMARY ANNUAL REPORT FOR
NATIONAL ROOFERS UNION AND EMPLOYERS
JOINT HEALTH AND WELFARE FUND

This is a summary annual report of the National Roofers Union and Employers Joint Health and Welfare Fund, EIN 51-0210922, for the year ended May 31, 2019. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Trustees of National Roofers Union and Employers Joint Health and Welfare Fund have committed themselves to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has a contract with Union Labor Life Insurance Company to pay stop loss claims in excess of \$275,000 incurred under the terms of the plan. Total premiums paid for the policy year ending December 31, 2018 were \$312,341.

Basic Financial Statements

The value of plan assets, after subtracting liabilities of the plan was \$17,730,427 as of May 31, 2019, compared to \$15,905,691 as of June 1, 2018. During the plan year the plan experienced an increase in its net assets of \$1,824,736. This increase included unrealized appreciation or depreciation in the value of plan assets, that is, the difference between the value of the plan's assets at the end of the year and the value of the plan's assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$10,234,500, including (but not limited to) employer contributions of \$9,442,582, participant contributions of \$60,599 and earnings from investments of \$505,235.

Plan expenses were \$8,409,764. These expenses included \$481,932 in administrative expenses and \$7,927,832 in benefits paid to or for participants and beneficiaries.

assets held for investment; and

transactions in excess of 5 percent of plan assets.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
